

Protection of Personal Data

The Law No. 6698 on the Protection of Personal Data ("Law") was adopted on March 24, 2016, and was published on April 7, 2016 and entered into force. However, according to Article 32 of the Law titled Enforcement, this Law; Articles 8, 9, 11, 13, 14, 15, 16, 17 and 18 came into force as of 07 October 2016. Law; It has been adopted in order to protect the fundamental rights and freedoms of individuals, especially the privacy of private life, in the processing of personal data, and to regulate the obligations and the procedures and principles to be followed by real and legal persons who process personal data. Therefore, this document, TriPass Bilgi Teknolojileri ve Turizm A.Ş. on behalf of the Law, to fulfill your obligation of disclosure arising from article 10 and "Personal Data Protection and Personal Data Sharing consent"; It is offered to users/visitors for information and review. This text contains summary information on personal data, for more detailed information and updated data policies, please refer to the "Personal Data Protection, Privacy Policy and Communication Permission Agreement" under the "Privacy" link on our website www.tripass.com.tr. Data Controller Information

TriPass Bilgi Teknolojileri ve Turizm A.Ş., whose detailed corporate information is published below. As a Data Controller, we will receive, use and process your personal data in accordance with the relevant legislation in accordance with the Personal Data Protection Law. The Data Controller representative to be appointed by TRIPASS will also be announced in the Data Controllers Registry when the legal infrastructure is provided and subsequently announced on the website with the extension www.tripass.com.tr in accordance with the legislation.

How can your Personal Data be processed?

TriPass Information Technologies and Tourism Inc. as a data controller, by our Company, our call centers, our affiliates or through our websites, mobile applications and social media pages and/or all kinds of channels, including but not limited to; your personal and/or sensitive personal data obtained with your consent; can be obtained, recorded, stored, stored, changed, updated, periodically controlled, rearranged, classified, stored for the period required for the purpose for which they are processed or as stipulated in the relevant law, in case of legal or service-related actual requirements. It can be shared/transferred with private-legal persons with whom it works or with public institutions and organizations that it is legally obliged to, and/or with relevant 3rd person real person/legal persons residing in Turkey or abroad, insurance companies, banks, legal or service dependent. may be transferred abroad or processed, including preventing its use, in case of actual requirements. In this regard, in accordance with the Law, obtaining, recording, storing, preserving, changing, rearranging, fully or partially automatic or non-automatic means provided that it is a part of any data recording system, of your personal or/private personal data that you share with our Company with your consent, All kinds of transactions performed on the data such as disclosure, transfer, takeover, making available, classification or prevention of use can be made by us.

What are the purposes and legal reasons for the processing of your personal data?

As TriPass, we will receive and process the personal and/or special quality personal data you share with us in accordance with the Personal Data Protection Law No. . In addition, to be used in all kinds of products and services within the scope of the legislation; to record the identity, address and other necessary information in order to identify the information of the transaction owner and to provide the service provided by our customers from TriPass; to arrange all records and documents that will be the basis of the transaction in electronic or paper environment; information storage, reporting, information, etc. requested by the legislation and authorized authorities. To comply with the

obligations, to offer the requested products / services and to fulfill the requirements of the service you request and the contract, the reasons in its content constitute the purposes and reasons for the processing of your personal and / or special quality personal data.

As a rule, although it is not possible to process personal data without the express consent of the person concerned, "it is necessary to process the personal data of the parties to the contract, provided that it is directly related to the establishment or performance of a contract", "Data processing is mandatory for the establishment, exercise or protection of a right. ", "It is mandatory for the data controller to fulfill its legal obligation", "the data subject has been made public by himself", "The data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject" and / or "It is clearly stated in the law In case of existence of any of the situations of "prediction of the law", it may be possible to process personal data without seeking the explicit consent of the person concerned.

Informing about the persons or organizations to whom we can transfer your personal data

For the above-mentioned purposes, the persons/organizations to which your personal and/or private data that you shared with us can be transferred with your consent; Our business partners, program-service partner individuals and organizations, banks, domestic / foreign organizations and other relevant third parties, from whom we receive services / cooperate to carry out our activities. In this context, we indicate that, since our Company acts as an intermediary in the provision of the campaigns and services of the business partners it works with, the necessary personal information about you can be shared with business partners, banks and/or other third parties depending on the scope of the requested service.

How is your personal data collected?

Your personal and/or special quality personal data, verbally, in writing or with your consent, through all kinds of channels including but not limited to our website, our sales and marketing department employees, digital marketing and call center/website/social media/organizers/business partners. can be collected electronically.

Explicit Consent to Personal and/or Private Personal Data

TriPass customers who purchase services or products from our website, users of our website and/or people who share other personal data can make a personal statement by clicking on the "membership agreement regulating the terms between TriPass and the user" under the heading "Terms of Use" published on our website. / or consent to the receipt, processing and domestic / international transfer of their personal data of special nature within the scope of the legal regulation.

If necessary permissions are not given for personal data, it should be taken into consideration that some features on the Site may be out of use, the service may not be offered partially or completely, in other words, service purchase may not be made. It should not be ignored that the provision, processing and transfer of personal data is necessary in order to purchase services, with the exception of exceptions. TriPass does not accept any responsibility and TriPass has no responsibility for the inability to sell services due to the lack of necessary consent for the provision, processing and/or transfer of personal data.

What is the Status of the Data Prior to the Publication of the Law?

Pursuant to the provisions of the Law, "Your personal data of a personal nature, which were processed before the publication date of this Law, will be brought into compliance with the provisions of this Law

within two years from the date of publication. On the other hand, consents obtained in accordance with the law before the publication date of the Law are deemed to have been accepted in accordance with this Law, unless a statement of intent is made to the contrary within one year". We would like to point out that since TriPass customers are deemed to have accepted the Terms of Use and Privacy Policy by becoming a member of TriPass and/or purchasing a TriPass card, and there are detailed regulations regarding the supply and processing of your personal and/or sensitive personal data in our Privacy Policies, the Law's You have the "lawful consent" given to us regarding your personal and/or sensitive personal data that we obtained and processed before the publication date. Pursuant to the Law, these consents of yours are deemed to have been accepted in accordance with this Law, unless a statement of intent is made to the contrary within one year.

What are your rights in accordance with the Personal Data Protection Law No. 6698?

Your rights pursuant to Article 11 of the Law; By applying to our company, your personal data; a) learning whether it has been processed, b) requesting information if it has been processed, c) learning the purpose of the processing and whether it is used in accordance with its purpose, ç) knowing the third parties to whom it has been transferred in the country / abroad, d) requesting correction if it is incomplete / wrongly processed, e) KVKK' To request deletion / destruction within the framework of the conditions stipulated in Article 7 of the Law No. f) to request notification of the transactions made in accordance with subparagraphs (d) and (e) listed above, g) to object to the emergence of a result against you because it is analyzed exclusively by automated systems ğ) you have the right to demand the compensation of the damage in case you suffer damage due to unlawful processing. Your rights in this context came into effect as of 07.10.2016.
